Burnett County Fair Report

Barbra Loomis attended the Burnett County Fair Property committee meeting on September 21, 2022. There are 3 projects that are being discussed. 1) fixing the cattle barn, 2) moving the carnival camping and 3) replacing a portion of the north bleachers. The fixing of the cattle barn would be between \$6,000 and \$9,000 depending on the solution. There wasn't an estimate for moving the camping as they are thinking of purchasing between 5-7 acres of land. Electrical would as need to be added wherever they move to. New bleachers will be about \$162,000.

Burnett County District 4 Supervisor Update 10/11/2022:

Land Use Committee:

Conditional Use Permit for 70 Unit Manufactured Home Park in the Town of Siren was approved.

Rezone Request for North Camp Properties II, LLC – Rezone from RR-3 and A-2 to RR-RC in the Town of Meenon was approved

Conditional Use Permit #CUP-22-14: Minerva Shores, LLC – Rental Storage in the Town of Swiss was postponed for the Town of Swiss to discuss this.

Beginning January 2023 public hearing notices will be sent to the respective town clerk and town chairperson.

Natural Resources Committee:

Wildlife Damage Program has been busier this year than the last couple of years. Lots of bear damage as well as deer damage. Several bear shooting permits as well as a few deer shooting permits were recommended.

Conservation Department is working with WI Geological and Natural History Survey (WGNHS) on the county wide groundwater inventory and plans are for starting in 2023.

USGS installed a new monitoring well in Crex Meadows by Dike 5/6 for additional info on the groundwater.

Health & Community Services committee:

Veterans Officer had an interview with Inter County Leader regarding the 2022 PACT Act in hopes of getting information to the public. This should be in the newspaper in the next few weeks.

HHS continues to recruit for 3 positions.

Covid has seen a decrease in the number of positive cases since last month.

The HHS director reported that October is domestic violence awareness month, as many as 1 in 4 women and 1 in 9 men face severe domestic violence.

<u>Update on Public Safety Jail Project</u>: County Administrator Nate Ehalt reported the final decision on the sanitary sewer system is to hook up to the Siren Sanitary District due to the possibility of having 124 inmate beds in the future. The approximate cost for the system will be \$60,000.00 - \$72,000.00 per year.

Infrastructure Committee:

The Highway department continues to have employee turnover, with one plow truck/driver position and two shop worker positions open.

One new highway maintenance worker hire will be going through the newly implemented CDL training program.

They have been doing new hire training and Snow plow operator training.

Projects are wrapping up for the season and preparation for winter is underway.
