Approval of Road Protection ordinance #01-2024

Annette Bethke said that the towns of Grantsburg and West Marshland have already signed this ordinance. Jeremy Gronski said we need to have the bottom line changed from Grantsburg to Anderson. He would also like to have Duke Tucker come to the next meeting to give more information on the ordinance before a decision is made. Annette Bethke said she would contact him to see if he would be able to attend the August Board meeting.

Treasurer's Report

Patsy Tucker gave the Treasurer report. As of June 30, 2024, the Town of Anderson has \$29,717.45 in checking and \$243,154.61 in the money market for total assets of \$272,872.06. This reconciles with all bank statements.

Fire Association Report

Mike Lee did not attend the Fire Association Meeting. Jeremy Gronski will check with him to see if he is still interested in being the Town of Anderson's contact person for the Fire Association meetings. Jeremy Gronski read minutes from the Fire Association meeting. Highlights are that Ramona Moody is a new Board member and that they are requesting a 2% increase in their budget from last year. This will be voted on at the September meeting. Ramona Moody stated that they had also changed accountants, but that was not reflected in the meeting minutes.
